

ARTHINGTON PARISH COUNCIL MINUTES

Minutes from the meeting held 4th October 2017, at the Village Hall, Arthington Lane.

1. APOLOGIES FOR ABSENCE:

2. DECLARED PECUNIARY & OTHER INTERESTS:

Cllr. D. Fox in relation to the planning application for 101 Breary Lane East (neighbours).

4. MINUTES OF PREVIOUS MEETING:

The minutes from the previous meeting of the council held on 12th July 2017 were read, **APPROVED, initialed and signed.** Proposed Cllr Fox, Cllr Lister seconded.

5. PC KARINA INGHAM

- Ward Manager PC Ingham discussed what action the police were taking against speeding and anti social behaviour in the parish. As well as the speed strips and surveys being carried out previously reported, number plate recognition cameras have also been used around the ward. As there have been no fatalities on Arthington Lane as a result of speeding, no further deterrents can be implemented. Officers randomly patrol ASB hotspots to deter offenders.

6. MATTERS ARISING:

- Cllr Lister reported that maintenance of the 3 benches has been completed by Cllrs Mernagh, O'Brien and Lister. Maintenance of telephone box and bus shelter is ongoing.
- The abandoned vehicle on Creskeld Lane has now been moved and the patch of road it was on has been resurfaced as it was previously missed.
- Sandbed Lane - on going - Clerk to contact Helen Burroughs for an update regarding the farmer's crops encroaching the bridlepath. Nick Flood also emailed regarding the BOAT proposal; the councillors agreed that there was no further comment to make on this.

Cllr Fox reported that the Breary Lane East site had revised landscape proposals but there was still not enough foliage; LCC highways have made comments to this affect and the councillors agreed that we would support those comments. Cllr Fox will draft our formal response for the Clerk to send in.
