17.23 Police Report. PCSO Hebden reported that there had been no crimes in Arthington or Pool in Wharfedale, there had been a burglary at a farm at the top of Bramhope. A minor traffic incident had occurred on Black Hill Road. Four calls had been received but none were relevant.
Issues with works vehicles parking at the bottom of Creskeld Lane was mentioned and PCSO Hebden said he would check it out and if it continues it can be reported on the website or by ringing 101.
