**27.23 Apologies for absence** – Apologies and reason for absence received from Cllr Stoddart-Scott and approved.

**28.23 To co-opt a Councillor to the vacant position.**

**Resolved:** That Juris Dambitis was elected to the vacant position and the Declaration of Office was signed.

**29.23 Declaration of pecuniary and other interests.** No declarations were received.

**30.23 Minutes of annual parish council meeting held on 11<sup>th</sup> July 2023**

**Resolved:** That the Minutes of the meeting held on 11<sup>th</sup> July 2023 were approved.

**31.23 Police Report.** PCSO Hebden reported that from 3<sup>rd</sup> Sept – 3<sup>rd</sup> October there had been no crimes reported. However, there had been incidents in August of a car stolen and farm machinery taken from Warren Lane and reports of quad bikes on Black Hill Road. PCSO Hebden advised that he would be leaving the Police force next week. There are still two PCSOs covering the area and he was unsure if a third would be brought in. The Parish Council wished PCSO Hebden well and thanked him for his support in the past.

**32.23 Public Participation** At this point any members of the public can bring forward any issues. No members of the public were present.

**33.23 To receive a report from the District Councillor**

Cllr Flynn had checked whether an application for a second SID had been sent to LCC and it would appear, despite there being surplus money in the fund, nothing had been received. He would send contact details to the Clerk and Cllr Lister to submit an application.

- Noticeboards – Two have been repainted, one to do.

As mentioned in Cllr Flynn's report, he will send details of the application, there is enough money in the fund.

**40.23 Clerk's report/correspondence and items brought forward by the Chair**

- The Clerk is still waiting for Cllr Stoddart-Scott to complete the bank mandate.
- The Clerk contacted HMRC and was told there is £27.64 in credit on the account. We cannot now pay by cheque as we have previously paid online.
- Remembrance Service – There is a combined service with Pool Parish Council who order the poppy wreath and send the bill to Arthington PC.
- There is a Teams meeting with LCC Planning on 18<sup>th</sup> Oct for anyone who is interested in the planning process.
- A smaller wagon is being used to collect refuse at Warren Lane to alleviate problems with access.
