Cllr Flynn advised that Highways were going to do a speed check on the road to see if a fixed speed camera should be installed. He had attended the Community Committee meeting where had had asked for a vote on a SID for Arthington Lane but this has been delayed due to information not being received. The Parish Council do not want a speed camera but do want the SID which money has been ring fenced for over the last two years. The next meeting of the committee is on 2nd December at 1pm and Members of the Parish Council are welcome to attend.

Cllr Flynn also reported that even though 80% had voted against parking charges at Golden Acre Park it was going ahead, though rather than using a phone app, cards can be used in the machine.
