25/01025/FU/NW - Single storey rear extension to existing side extension. Rooflight to existing side extension. Demolition of existing deck and creation of split-level stone terrace. Full-height glazing window and door on rear bay window. New large window to rear, side and replacing door with window to the side – 33 Creskeld Lane, Bramhope.

Resolved: The Parish Council neither supports or objects to this application. This is a positive building in the conservation area and the Parish Council has some concerns over the impact of the proposed new windows to the rear (western)elevation and which may have some impact on the street scene. In particular the large expanses of glass on the window
